Well not once did any company respond. So I called ISC "numerous" times telling them to send me some kind of proof that they are even sending brochures out. Well they never did. One employee there even lied to me & said they sent something to me but they never did. I have just recently seen on the internet that ISC has been sued before & have given refunds for the last couple of years I have been trying to figure out how to get my \$ back like all of these other people because I feel that they haven't done what they say they are doing. I regret paying \$10,000!! Have I been scammed & what can I do to try & get a refund?
